- 4. Arbitration by Sparks Energy Sdn. Bhd. against Idiwan Solar Sdn. Bhd. in relation to the Machang Project, which is not related to the Group.
- 5. The suit by BGMC Corporation against DPI Solar 1 for abuse of process in relation to the legal proceedings as disclosed on paragraph (a)(i) on page 12 of the First Announcement.
- 6. The suit by BGMC Bras Power and Idiwan Solar. Sdn Bhd. against Kazuomi Kaneto, DPI Solar 1 and Sparks Energy 1 for abuse of process in relation to the Suit (as disclosed in the Second Announcement).
