5.	The form of proxy must be signed by the appointor or his/her attorney duly authorised in writing or, if such appointor is a corporation, must be either under its common seal or under the hand of an officer, attorney or other person authorised to sign the same.		
6.	In the case of joint shareholders, the signature of any one shareholder will be sufficient but the names of all the joint shareholders should be stated.

Where there are joint holders of any Share, any one of such joint holders may vote at the 2023 AGM, either in person or by proxy, in respect of such Share as if he/ she were solely entitled thereto, but if more han one of such joint holders is present at the 2023 AGM, that one of the said persons so present whose name stands first on the register of members of the Company in respect of such Share shall be entitled to vote in respect thereof.

In order to be valid, this form of proxy must be completed, signed and deposited at the Company's branch share registrar in Hong Kong, Boardroom Share Registrars (HK) Limited (the "Hong Kong Branch Share Registrar") at Room 2103B, 21/F., 148 Electric Road, North Point, Hong Kong together with a power of attorney or other authority, if any, under which it is signed (or a notarially certified copy thereof), not later than 48 hours before the time appointed for holding the 2023 AGM or the adjournment thereof. Completion and return of the form of proxy shall not preclude Members from subsequently attending and voting in person at the 2023 AGM or the adjournment thereof, should they so wish, and in such event, the form of proxy shall be deemed to have been revoked.
